ACTION ALERT!

HB 297 may be the most aggressive initiative, essentially lawyering up for a fight with Compact states over Utah's paper water rights on the Colorado River heading into negotiations for a new drought management agreement by 2026. Instead of forward-looking cooperative agreements with our neighbors for sharing a shrinking river serving 40 million citizens to conserve water, Utah thinks it's better to "punch back" - all to build the Lake Powell pipeline project. The bill will be debated on the House floor this week. **Call, text and email Republican legislative leadership and tell them to get real and double down on conservation, ocean desalination agreements and regional shared storage efforts!**

News of Week Three (Week # 3)

The bill to merge DEQ and DNR is still not public. Either it's being shelved for this Session or they are waiting to roar it through at the last minute. If the latter, we must respond quickly. Keep up the pressure!

SB 130, the big Smithfield CAFOs bill is on the Senate calendar for action early this week and will move to the House. We will keep you posted on opportunities to push back against this dangerous expansion of

SJR 7, the resolution to grant legislative approval to Energy Solutions for a new landfill for slightly radioactive rubble from decommissioning nuclear power plants nationwide won easy Senate approval and now heads to the House for further debate.

Two bills we oppose unfortunately are moving ahead. HB 209 would hike the registration fees for electric and hybrid vehicles by 2 to 5 times, making Utah's fees the highest in the nation. And HB 17 would ban cities and counties from passing ordinances that would require use of renewable energy sources in new buildings.

Budget News

First thing Monday morning in NRAEQ Appropriations is a funding request for a new Utah Lake Authority. It's unclear

what the purpose, need and intent may be. We'll listen in and report on it tomorrow. Numerous other Requests for Appropriations will be heard, including the last 3 of 5 good proposals from Rep. Hawkes and National Audubon to do important research and planning related to Great Salt Lake. We'll also report on these RFAs and urge support from allies.

Other RFAs we're following would fund RS2477 lawsuits and public lands fights with the feds, a Bridal Veil Falls state monument and Utah's Natural Resource Legacy Fund.

Appropriations Subcommittees will prioritize their requests for new money this week - almost all one-time but over a billion dollars. NRAEQ Appropriations will review their list of requests after Monday's meeting and vote on Wednesday. Executive Appropriations Committee will meet on Thursday afternoon to begin the process of deciding which RFA's will be funded. So weigh in now if you have opinions on what should be – or should not be – funded!

What's Ahead

Schedules shift this week. With Appropriations Subcommittees concluding their business Wednesday, Standing Committees will meet 8-10 Thursday and Friday, and 2-5 every day but Thursday. Both chambers will be on the floor each day from 11 to 11:50, and from 2-5, except Thursday.
