# **About the Legislative Update**

## **ACTION ALERT!**

Rep. Brammer's Utah Lake Authority bill still has not been made public, which is a positive sign that it's getting pushback behind the scenes. Reportedly, the bill would effectively usurp state authority (FFSL) to manage and control the bed of the lake and shoreline up to 4,489 in elevation for "restoration" and development. It would also jeopardize the primacy of the Division of Water Quality. The unelected Board could issue bonds and take sales tax and property tax increment revenue, much like the Inland Port. Let legislators know that we want the lake and its water quality improved - using sound science and good management - not exploited for private gain!

HB 297 to create a Colorado River Authority is "circled", awaiting action on the House floor. There may be some amendments, but this is still bad policy, so keep up the pressure to defeat it!

# **News of Week Four (Week #4)**

The best news and biggest relief of the Session so far: the proposed merger (hostile takeover) of DEQ into DNR is dead! At least for this Session. Rep. Casey Snider's bill, HB 346, moves the Office of Energy Development and the Office of Recreation under DNR, but leaves DEQ and PLPCO where they should be.

SB 130, the big CAFOs bill, passed the Senate and will be heard in the House NRAE Committee Tuesday afternoon. Despite substantial changes, this is still a bad bill that is part of a major initiative Smithfield Foods to expand its operations in Millard County and for CAFOs to be able to operate in more than 100,000 acres of land in central Utah.

SJR 7, the resolution to grant legislative approval to Energy Solutions for a new landfill for slightly radioactive rubble from decommissioning nuclear power plants nationwide won easy Senate approval and now heads to the House for further debate. HB 295 to ban baiting of big game and regulate trail cameras advanced to the House floor. It is improved but still could benefit from additional amendments.

# **Budget News**

Appropriations Subcommittees concluded their prioritizing of requests for new money and will not meet again until further notice, if at all. Executive Appropriations will await the mid-February revenue estimates and start to make the big budget decisions on what gets funded.

Three requests for appropriations from Rep. Hawkes and National Audubon, CO River Stakeholder Process, GSL Groundwater Studies, and Water & Land Use Planning got reasonably high priorities from NRAEQ. Two others were well down the list. Funding for a Bridal Veil Falls state monument was in the middle of the GSL requests, while unfortunately money for RS2477 lawsuits ranked #9 of 51.

## What's Ahead

Two important bills we support will be heard this week: HB 281, addressing local approval of Cedar City's groundwater grab, and HB 263 to create a Clean Energy Fund.

Standing Committees will meet 8-10 AM Tuesday through Friday, and 4-6 PM every day but Friday. Both chambers will be on the floor each day from 10 to 12, and from 2-3:50, except when floor action goes from 2-5 PM.
